#### INSTRUCTIONS TO ABSENTEE VOTERS

1. Applicants must fill out in full the statements on this form and personally sign it.
2. Mail or deliver this application to the office of the District Clerk, Cazenovia Central Schools, 31 Emory Avenue, Cazenovia, NY 13035, no later than 3:30 pm on May 9, 2023 (one week before the vote/election) in order to receive the Absentee Ballot BY MAIL.
3. Any qualified voter who may be unavoidably absent on the day of election may deliver an application IN PERSON to the office of the District Clerk no later than 3:30 pm on May 15, 2023 (one day before the vote/election) in order to obtain an absentee ballot.
4. This application is good only for the vote to which it specifically pertains. You must, unless permanently disabled, renew your application for each vote/election if you are still eligible to vote absentee.
5. A list of all persons to whom absentee ballots have been issued shall be available in the office of the District Clerk until the day of the vote/election (May 16, 2023).
