INSTRUCTIONS TO ABSENTEE VOTERS

- 1. Applicants must fill out in full the statements on this form and personally sign it.
- Mail or deliver this application to the office of the District Clerk, Cazenovia Central Schools, 31 Emory Avenue, Cazenovia, NY 13035, no later than 3:30 pm on December 5, 2023 (one week before the vote/election) in order to receive the Absentee Ballot <u>BY MAIL</u>.
- 3. Any qualified voter who may be unavoidably absent on the day of election may deliver an application <u>IN</u> <u>PERSON</u> to the office of the District Clerk no later than 3:30 pm on December 11, 2023 (one day before the vote/election) in order to obtain an absentee ballot.
- 4. This application is good only for the vote to which it specifically pertains. You must, unless permanently disabled, renew your application for each vote/election if you are still eligible to vote absentee.
- 5. A list of all persons to whom absentee ballots have been issued shall be available in the office of the District Clerk until the day of the vote/election (December 12, 2023).
